FOX WELDOOR WELDED CORNERS ARE WARRANTED NOT TO SAG OR FAIL (SEPARATE) UNDER NORMAL RESIDENTIAL USE. FOX WELDOOR HINGES ARE WARRANTED NOT TO BECOME INOPERATIVE OR BREAK WHEN PROPERLY INSTALLED WITH JAMB ADJUSTING SCREWS. FOX WELDOOR WILL WARRANTY ANY FRAME OR INSERT CORNER AGAINST BREAKAGE. FOX WELDOOR WARRANTS FOR ONE (1) YEAR LOCKS, CLOSERS, AND HANDLES.

SERVICE UNDER THIS WARRANTY IS AVAILABLE BY ADVISING FOX WELDOOR OR ONE OF ITS DISTRIBUTORS OR SELLING DEALER AFTER DISCOVERY OF DEFECT.

UPON RETURN TO FOX WELDOOR, WE WILL UPON INSPECTION AND AT OUR OPTION, REPAIR OR REPLACE COMPONENTS OR PARTS AT NO CHARGE. MANUFACTURER RETAINS THE OPTION TO USE NEWER PARTS WHEN OUTDATED PARTS ARE NO LONGER IN USE.
